# 2021-2022 Accomplishments

- Continued partnership with the United Way of Delaware Stand by Me program to provide financial literacy education programs for parents.
- Completed an annual financial audit with no findings.
- Received an \$11,1222 grant from the Delaware Community Foundation to provide literacy learning kits to children.
- Received an American Rescue Plan Grant for \$513,299 to provide oneon-one child-to-teacher support over the summer and offer retention bonuses for staff throughout the 2021-2022 and 2022-2023 fiscal years.
- Awarded carryover funds in the amount of \$1,026,731 from the fiscal year 2020-2021, which were moved into the 2021-2022 fiscal year.

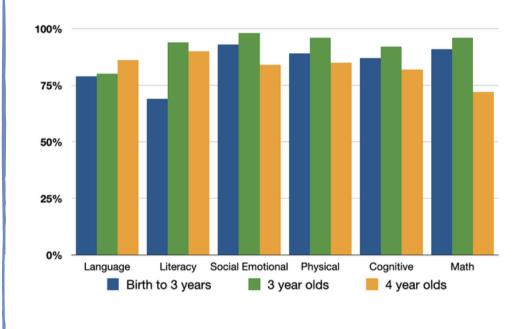
Funding

- Returned to in-person learning.
- Improved and enhanced the virtual learning curriculum to continue to provide instruction during the pandemic.
- Provided a 4-week summer enrichment program in July 2021 for all children.
- Implemented Ready-Rosie Parent Curriculum for enrolled families.
- Transitioned 100% of age-eligible children to kindergarten in the fall of 2022.
- Implemented a vaccination policy as of 11/1/2021 to protect all employees and enrolled children.

# **Program Review**

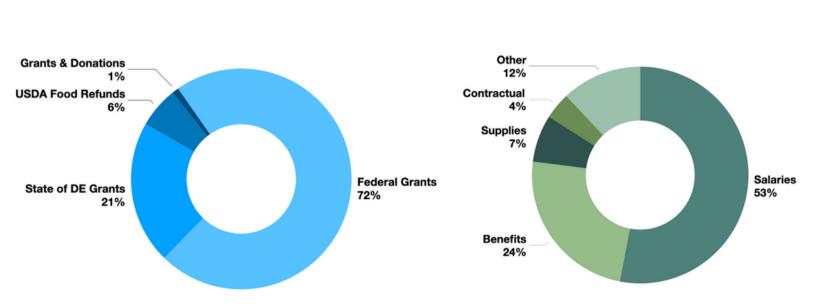
## **Program Review and Self-Assessment Findings**

New Castle County Head Start, Inc. conducted a detailed program self-assessment in accordance with the federal Head Start performance standards for the 2021-2022 program year. Below is a summary of the results:

- The area of Program Design, Management, and Quality Improvement was found to have strengths in the knowledge of the community, strategic planning process, and fiscal operations.
- The area of Designing Quality Education and Child Development Program Services was found to have strengths for formal agreements with all Local Education Agencies (LEAs), Summer Enrichment, and Coaching for the educational staff.
- The area of Designing Quality Health Program services was found to have strengths in response to COVID-19 concerns and health and safety procedures.
- The area of Designing Quality Family and Community Engagement Program Services strengths include our overall response to the pandemic, including a virtual learning model, support to families (food, supplies, educational materials), and the availability of Financial Coaching for all families.
- Developing Effective Eligibility, Recruitment, Selection, Enrollment, and Attendance (ERSEA) Strategies and Fiscal Infrastructure areas had strengths in Eligibility determination system with supervisory approvals and 100% compliant Financial and Pension audits.

The only areas of concern were training, communication, and translation technology. Due to staffing shortages and the pandemic, these areas need more attention.
